Association News and Meeting Minutes

MEETING MINUTES SEPTEMBER 15, 2011

HOLIDAY INN, INDEPENDENCE

The General Membership meeting of the Cuyahoga County Police Chiefs Association was called to order at 1210 hours by President Harris.

Roll Call Chaplain Kostura led the Pledge of Allegiance and the Invocation. Secretary Treasurer Loftus called the roll of officers. All Officers were present. Members and guests introduced themselves.

Approval of Previous Meeting Minutes *A motion to accept the minutes of the regular membership meeting of June 20, 2011 as distributed, was made by Chief Dease and seconded by Chief Kostura. Motion Passed.*

Financial Report Secretary Treasurer Loftus reported that our account balances are as follows:

A Motion to accept the Financial Report was made by Chief Viland and seconded by Chief Baumgart. Motion Passed.

Executive Director's Report Bob Bruckner.

- The website has been updated to include a link to "Links" and a link to the complete "CCPCA-Ohio-75 Year History" authored

by former Executive Director, Marion Taylor.

- The CCPCA will be participating as a sponsor of the Ohio Law Enforcement Expo at the IX Center, on March 13-14, 2012.

Legal update Steve Parisi.

- Another CPD officer has been charged with misusing the LEADS database. Steve feels that the officer will be indicted for a felony and plead to a misdemeanor.
- The U.S. Supreme Court has ruled that vehicular flight, with a gun, is a "violent felony" under the "Armed Career Criminal Act" and can trigger a mandatory 15 year federal prison sentence on a third offense.
- Steve commented on the need for department policy and procedure concerning sexual assault cases and proper evidence collection and handling in those cases.
- An Ohio Supreme Court ruling will allow denial of damages if it is found that a lawsuit seeking damages from a governmental body for illegally destroyed public records was motivated for a quest for cash rather than a sincere interest in obtaining public records.
- The U.S. Supreme Court has ruled that police may have to give Miranda warnings to juvenile suspects in some situations where they could question adults without doing so.

- An Athens County judge has ruled that while the Intoxalyzer 8000 meets the minimum standard for admissibility, defense attorneys should be allowed, on a case-by-case basis, to use expert witnesses to attack the results. Other courts have also found problems in admitting test results from this breath tester.
- Steve commented concerning the difficulty of enforcing a texting while driving ban recently approved by the Ohio House and expected to become law soon.
- The U.S. Supreme Court has reaffirmed its ruling from two years ago that court testimony concerning scientific tests must come from the actual tester who did the work. Surrogate testimony will not suffice.
- In November the U.S. Supreme Court will likely rule on the use of eyewitness evidence and which kinds of eyewitness identifications warrant a closer look from judges. Other state courts are also reviewing the use of eyewitness evidence.
- The Ohio Supreme Court has adopted a new rule that requires courts in the state to hire foreign language or sign language interpreters in some cases. Steve commented on the need for competent, trustworthy interpreters if used by police departments.
- Steve cautioned that Miranda Rights must be given to prisoners in jails or prisons until the U.S. Supreme court hears a current case filed by 35 states alleging that a 6th Circuit court ruling affords greater rights to prisoners than to other citizens concerning in custody interrogations.
- Steve cautioned Chiefs to make sure what their cities insurance covers regarding the use of tasers and what the policy may require for complete coverage.

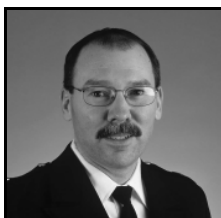
